The Marie J. Philip Award recognizes a Deaf individual who has shown significant dedication to and involvement in the field of interpreting on local, regional and national levels.

RECIPIENT WILL BE PRESENTED WITH:

- an engraved plaque
- full registration for the next RID Conference

CRITERIA:

Failure to follow the rules below will render the application void.

The nominee must (a) be Deaf or Hard-of-Hearing, (b) promote the field of interpreting for both the Deaf and hearing communities.

The nominee must:

- have demonstrated leadership on local, state and/or regional levels
- have made significant contributions to the profession and to the American Deaf community

Each nomination must include:

- application
- letter of nomination which includes a brief biography of the nominee, stating:
 - a) place of employment and position held
 - b) major accomplishments locally, regionally and nationally
 - c) rationale for nomination

8 copies of documentation for each Committee member, the Board liaison, and the National Office staff representative must be submitted. All material will be sent to the National Office where the staff representative will send copies to the Committee members and Board liaison.

CYCLE:

Nomination material must be postmarked by March 1.

Awards will be announced at the National Conference.
